B. Superintendent

Superintendent Abrahamson discussed the student enrollments for the current school year. Currently, the count is 1,699 compared to 1,727 in October 2012. Sixteen students are attending one of the on-line schools. In 2012, twelve students attended the on-line schools. The formula of the number of students allowed to attend an on-line school is one percent of the district's students. Based on this calculation, the district is allowed 17 students to attend the on-line schools.

The public forum will be Wednesday, October 16 at 6:00 p.m. in the Grinnell High School auditorium. Smith, Brown, and Knobloch along with Abrahamson, Johnson, and Maintenance Director Shawn Edelen will be answering questions. Smith stated it is important the board hear from the community at the October 16 publicforum, and at any additional public forums.

Superintendent Abrahamson stated he has asked the building administrators to attend the second monthly school board meeting. The second monthly board meeting will also have presentations from teachers and students.

This committee is a combination of the former transportation committee and the former buildings and grounds committee. Knobloch and Smith will be members of the negotiation committee.
